Virginia Association of Assessing Officers Professional Designation Award

- "The IAAO's Professional Designation Program provides a mechanism to unify and standardize the designation process, it must be recognized that IAAO professional designations represent an ultimate professional objective."
- In an effort to support the IAAO's Professional Designation Program, and encourage, support, and help facilitate each VAAO member and reaching their ultimate professional objective. The VAAO hereby institutes an award, for successful completion and written confirmation of the granting of a IAAO Professional Designation. The award shall be administered as follows:
- Upon receiving a CAE designation; the sum of \$500.00 shall be the award.
- Upon receiving any IAAO designation other than CAE, the sum of \$300.00 shall be the award.
- A total lifetime award for completion of multiple designation programs shall not exceed \$800.00.
- Presentation shall be made, along with a memento from the VAAO at the annual Education Seminar or Annual Conference, by the Professional Designation Program Committee. The committee shall request from the VAAO Treasurer and the Treasurer shall have authority to issue the funds for these awards.
- The effective date for this award program is January 1, 2013. Any active member of the VAAO with a Designation Certificate date on or after this date shall be eligible for this monetary award.
- This award program may be cancelled, amendment, or replaced without notice to the VAAO membership, by the VAAO Board of Directors.
- In any event there is a dispute over the granting of any award, the VAAO Board of Directors shall be the final arbitrator.

 The following amendment to Section 11 of the by-laws is submitted for comment. The final product was submitted at the December 7 meeting and was passed with the required vote of two-thirds of the board members attending.

Previously:

Section 11. Professional Designation Program Advisory Committee: The Professional Designation Program Advisory Committee shall maintain contact with all IAAO candidates in Virginia, to encourage regular candidate club meetings and to provide assistance to those candidates working towards a professional designation. The committee shall consist of the IAAO appointed regional Professional Designation Advisors, and any number of additional members entitled Candidate Club Coordinators, appointed each year as deemed necessary by the VAAO president. Of the above mentioned members, one (1) will be appointed by the president to serve as chairperson and must possess an IAAO designation.

As Amended:

Section 11. Professional Designation Program Advisory Committee: The Professional Designation Program Advisory Committee shall maintain contact with all IAAO candidates in Virginia, to encourage regular candidate club meetings and to provide assistance to those candidates working towards a professional designation. The committee shall consist of the IAAO appointed regional Professional Designation Advisors, and any number of additional members entitled Candidate Club Coordinators, appointed each year as deemed necessary by the VAAO president. Of the above mentioned members, one (1) will be appointed by the president to serve as chairperson and must possess an IAAO designation. The committee chair will be responsible for administering the VAAO Designation Award which shall include keeping records of all recipients and notifying the Officers and Board members when an IAAO designation has been earned.

Keeping Current with Changes in Legislation Affecting Property Assessments

A Resource Guide for Virginia Property Assessors

The majority of the legislation passed by the Virginia General Assembly during a legislative session or calendar year becomes effective July 1 of that year, unless vetoed by the Governor or some other technicality befalls it. Modern property assessment practices require that assessors keep up to date with current legislative proposals, laws, and court decisions. The following are suggested resources to help you keep up to date with these changes. Several statewide resources will provide a review of legislative changes that will need to be considered for upcoming assessments. Suggested examples (shown in italics) are also listed so that you can add local city and county resources to customize your own list.

This resource guide was prepared when the author was serving as the city assessor for the City of Manassas Park, Virginia. Therefore the suggested examples listed are for that jurisdiction but you are encouraged to revise this list to include your own resources.

Secretary's Report: David Sanford, CAE - Present

President Larry Mackereth, CAE asked the Secretary to read the minutes from the July 12, 2012 meeting. Ron Agnor, First Vice President made a motion to dispense with the reading of the minutes. The motion was seconded by Director Pam Stepanick. There was no discussion and all voted in favor. Ron Agnor, First Vice President made a motion to approve the minutes. Reporting to the President Elect: William Marchand

Education Committee 2013: Jeff Davis and Elizabeth Craft – Present. President Elect Marchand commented upon the positive efforts to date and thanked the Co-Chairs. Co-Chair Jeff Davis provided details regarding the July Seminar. The host Hotel has changed this year and will be the Omni Hotel, Charlottesville. The room rate will be \$139 per night, with rates extended through the weekend for attendees wanting to stay a night or more beyond the Seminar dates. The Seminar dates are July 17th – July 19th. There will be no parking fees charged.

Audit and Finance Committee: Steve Esenbock – Present

Chairman Steve Esenbock – Present, commented regarding the importance of keeping accurate receipts.

Annual Meeting 2014: Don McKigney – Present. Chair mentioned that the Norfolk Sheraton Waterside will be the Conference Hotel. The Hotel is currently undergoing renovations. Conference date has yet to be determined.

Arrangements Committee 2013: Catherine Brincefield – Absent. President Larry Mackereth gave the report for Arrangements (See Attached).

Membership Committee: Richard Paul, CAE, SRA - Present Chairman reported 4 new members, bringing the total for the year to 42.

PDP Advisory Committee: George Barham, RES - Present.

Chairman George Barham, RES presented two items for consideration. The first was in reference to a survey and additional information (see attached flyer) regarding member interest in an AAS preparation class/workshop. Chairman indicated he would extend deadline on survey and is actively exploring venues central to the State. Chairman then presented the second item for consideration in the form of a recommendation for monetary Designation Awards (see attached recommendation). Publicity Committee: Ryan Davis - Present

Chairman Ryan Davis reported that another issue of the Network would be published in the next two weeks, although there was still time to make a submission prior to the following Friday. He also indicated his intent to acquire a laptop and new software.

Past President Daniels, CAE had no report.

Legislative Committee: Jim Hester, CAE – Absent

Nothing significant to report at this time.

Use Value Committee: Bruce Lowe – Present

Chairman Bruce Lowe reported that there have been significant new Use Values established and cautioned jurisdictions should make themselves aware of those new values.

Regional Seminar Committee: Tammy Carroll, CAE – Present

Chairwoman Tammy Carroll had no report.

Parliamentarian: Wendell Ingram – Present

No report was given.

Technology Committee: Greg Daniels, CAE- Present.

Past President Greg Daniels, ČAE reported that Jonathan Garner has been drafted to take over the website. Furthermore, the website was a victim of a "pharmaceutical" attack and therefore some ads appeared for various products. The "hack" came through an IP address and has since been blocked. The site itself is clean. President Mackereth acknowledged that despite minor issues, Greg Daniels is to be commended for bringing the organization forward in the area of technology.

Historian: Steve Boyer – Absent

President Greg Daniels, CAE reported scanning all of the historic documents is almost 100% complete, and encouraged people to send any additional historic documents.

Commissioner of Revenue Liaison: Frankie Edmondson - Present

COR Liaison Frankie Edmondson reported that the COR's would like to have more interaction and participation with VAAO in future. At the Annual CORVA Conference held recently in Bristol, Members discussed redefining goals, with an emphasis on not duplicating efforts with other industry organizations. Two primary concerns/issues relate to effective educational offerings that are cost efficient. Other goals include trying to increase memberships in VAAO and IAAO, in addition to promoting complimentary educational offerings. Liaison believes the partnership is worth supporting, as it benefits both organizations and disciplines. Frankie encourages VAAO to dialogue with their respective COR's regarding dual participation that is economically sound and returns tangible worth to both Organizations.

IAAO Representatives: Wendell Ingram- Present

IAAO Representative Wendell Ingram reported that IAAO "Two for \$200" new member campaign promotion was still in effect. He remarked that the IAAO was in the process of rebranding and encouraged IAAO Webinars. The fees for multiple designations have been addressed and approved by the Executive Board. Beginning next year, the 1st Designation pays full dues; subsequent held designations pay one half dues per designation per Designee. Goal of accredited member is as a pathway to designations. Some discussion about good fiscal health of IAAO followed.

Unfinished Business:

Arrangements Committee 2012: Co-Chairwoman Janice Hudgins reported a profit was made at the Annual Conference held in Virginia Beach, the final amount to be determined upon completion of audit.

It was determined that a motion was not entertained to approve the Professional Designation Award recommendation presented by Chairman George Barham. Director Ryan Davis made motion to approve designation award, Director Jeff Davis seconded and all voted yes.

New Business:

- 1. Charlie Crowson agreement, Legislative Liason contract lower this year due to shorter session. Motion made to continue for \$6,000 (Ryan Davis), Pam Stepanick seconded. There was no discussion and all voted in favor.
- 2013 Budget Adoption. Billy Driver, Treasurer presented the 2013 Budget. Budget adopted as amended (see attached). Bruce Lowe made the motion, President Elect, Bill Marchand seconded, all voted in favor.
