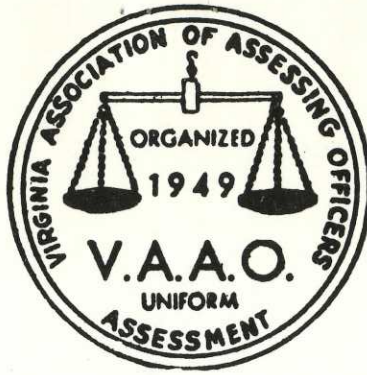
Needless to say, this was a real shock and a great loss to us.

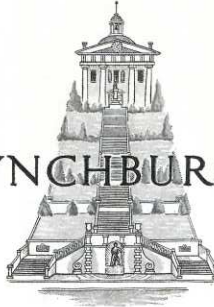

Stroke Is Fatal To Samuel L. Lee

LYNCHBURG, Sept. 13—(AP)—Samuel Lile Lee, 55, Lynchburg city tax assessor since 1953, died Thursday night in Virginia Baptist Hospital after suffering a stroke Tuesday.

He attended E. C. Glass High School, Virginia Episcopal School, Shenandoah Military Academy and the University of Virginia, from which he received a law degree.

After graduating from law school, he practiced law in Charlottesville until entering the army, serving in the Pacific Theater for three years.

He returned to Lynchburg to engage in the real estate business, serving as president of the Lynchburg real estate board in 1950.

In addition to his mother, Mrs. Virginia Lile Lee, survivors include his wife, Mrs. Virginia Goodman Lee; a son, and a daughter.

A funeral service will be conducted at 11 a.m. Saturday at St. Paul's Episcopal Church with burial in Spring Hill Cemetery.
